2. HAZARDS IDENTIFICATION SUMMARY

KEEP OUT OF REACH OF CHILDREN

May cause mild eye and skin irritation. Avoid contact with skin, eyes, open cuts, or sores. In cases of contact, flush with water. Get medical attention for eyes. This blended dry fertilizer is mixture of Ammonium Sulfate, Biosolids and Monoammonium Phosphate. Nausea and vomiting could be expected upon large dose ingestion. The acute digestive effects are described as nausea, chills and diarrhea. Eye or skin contact with these products could cause irritation (particularly in sensitive persons) and respiratory irritation could be expected from the unprotected inhalation of fertilizer dusts. Product user should avoid prolonged or repeated skin contact by wearing impervious gloves, long sleeve shirt, long pants, socks and rubber boots. Goggles for eye protection are recommended. Wash thoroughly after handling and using this product.

This product is a multi-colored granule with dusty odor. Primary routes of entry are inhalation eye contact and skin contact.

4. FIRST AID MEASURES

If in eyes : In case of contact, immediately flush eyes with plenty of water for a minimum fifteen minutes. Hold upper and lower lids apart to insure rinsing of the entire eye surface and lids. Do not use boric acid to rinse with; sulfur in an acid irritant.

If on skin : No adverse effects. Skin irritation may be aggravated in persons with existing skin lesions. Wash exposed clothing separately before use

If swallowed : If conscious, drink 1 or 2 glasses of water. Get medical attention. Never induce vomiting or give anything by mouth to an unconscious person.

If inhaled : Move patient to fresh air. Watch for signs of allergic reaction. Use a bronchodilator inhaler if directed by asthma patient. Keep victim warm and quiet. If not breathing, clear airway and start mouth-to-mouth resuscitation. If hearth has stopped beating, start cardiopulmonary resuscitation.
